SECTION I: GENERAL INFORMATION, DISCLAIMER & INSTRUCTIONS FOR BIDDERS.

1. INTRODUCTION OF THE BANK

The West Bengal State Co-operative Bank Limited having its registered office at 24-A, Waterloo Street, Kolkata 700069 is a 100 years old Banking Institution working as an Apex Bank of all Co-operative Banks of West Bengal. Serving the needs of peoples from remote areas to State Capital, Bank have 43 branches in South 24 Parganas, North 24 Parganas, Coochbehar Districts and in Kolkata & Siliguri working on the CBS platform.

1.1 Purpose of the Tender

Tenders are invited on behalf of the State level Implementing Agency for the **Centrally Sponsored Project (CSS)** initiated by the Govt of India for '**Computerisation of Primary Agricultural Credit Societies' (PACS)** through Government e-Marketplace (GeM) from the eligible OEM/sellers matching the eligibility criteria for supply & installation of Hardware Items with reference to Specification wise Quantity (BOQ) to be supplied at **606 PACs** located at **different districts of the State of West Bengal**. For details please follow the Delivery Location under **Annexure-4**.

The procurement is intended to follow two bid systems viz. Technical Bid & Commercial Bid from the firms who have successfully handled and completed supply of similar nature product **and having their/OEM Branch Office/ Functional Service Center in the State of West Bengal**. First, the Technical Bid submitted within the stipulated time will be opened and evaluated. Commercial Bid will only be opened for the seller who has successfully matched with the technical eligibility criteria mentioned here-in-after. The supply as well as necessary installation commissioning and testing of the hardware items to be completed within 56 days from the date of awarding the contract.

1.2. Time of completion

56 (Fifty Six) Days from the date of awarding the contract. The time frame is conclusive. No extension will be allowed otherwise the Bank and/or the State level Implementing Agency considers that there is valid reason for delay of the supply and express its consent in written. Penalty equivalent to 0.3% of the contract value only per day will be deducted for the delay beyond time frame of 56 (fifty Six) days upto maximum penalty equivalent to 5% of the project value. However the above time frame cannot be stretched beyond 90 days, else the Bank may at their sole discretion cancel the contract.

For the convenience of hassle free supply of the hardware items to selected PACS, the details of the Nodal Officer from every district has been provided as per **Annexure-5**, who will coordinate between the selected vendor with the PACS.

1.3. EARNEST MONEY DEPOSIT / BID SECURITY/ PERFORMANCE SECURITY DEPOSIT:- Giving cognizance to Office Memorandum No.F.9/4/2020-PPD dated 12th November,2020 of Government of India, Ministry of Finance, Department of Expenditure Procurement Policy Division, no Earnest Money is required to submit with the Tender. However the bidders have to submit declaration as per **Annexure-C**.

More fully, upon acceptance of the bids, the successful Bidder have to submit **Performance Security Deposit** in the form of Bank Guarantee equivalent to 3% of the value accepted.

1.4. Pre-Qualification Criteria & Criteria for Short Listing to be submitted with Technical Bid:- The firms must fulfill the following eligibility criteria to be submitted with relevant documents to be considered for Technical Evaluation:

- a) The Bidder/OEM must have Branch Office/Functional Service Centers in the State of West Bengal and the details of address and contact no of such centers/ offices is to be provided while bidding.**
- b) Turnover of the Bidder for the last three consecutive years in each year of 2020-2021, 2021- 2022 & 2022-2023 shall not be less than 24 Crores. [Please submit Audited Accounts of last three years and IT Return for last three years]**
- c) The Bidder must be in profit for the last three consecutive years in each year of of 2020-2021, 2021- 2022 & 2022-2023. [Please submit Auditor's Certificate subscribing his registration number]**
- d) Bidder must be in the same business for at least last five years [Please submit Purchase Order/ GeM Contract in last five years]**
- e) Bidder must be an Authorized Dealer/Distributor/Service Partner/Representative of OEM [Please submit appropriate Certificate issued by the OEM]**
- f) The Bidder must not be blacklisted since its functioning [Please submit self declaration in bidder's letter head pad as per Annexure-D]**
- g) The Bidder shall submit declaration that the bid has been submitted fully knowing the terms & conditions of the tender [Please submit self declaration in bidder's letter head pad as per Annexure-B]**
- h) OEM Quality Certification:-**
The OEM must be ISO 9001-2015, ISO 20000 compliant **[Please submit copy of certificates]**

In addition to the above, the Bidder has to submit the following self attested documents along with the Technical Bid mandatorily: -

- ii) Copy of PAN Card in the name of the Bidder**
- iii) Copy of GST Returns of last three years i.e. of 2020-2021, 2021- 2022 & 2022-2023**

- vi) Certificate of compliance with the technical specification of items issued by the OEM**
- vii) Submission of Product information in reference to Annexure-A [to be submitted in letterhead pad]**
- viii) Submission of Bid Security/EMD Declaration in reference to Annexure-C [to be submitted in letterhead pad]**
- ix) Submission of declaration for 5 years Comprehensive Onsite Warranty in reference to Annexure-E [to be submitted in letterhead pad]**
- x) Submission of check list in reference to Annexure-2**
- xi) Any other documents as may be specified subsequently**

The short-listing of the applications received and final selection of vendors for supplying equipment to the bank will be done by carrying out evaluation of various parameters/criteria fixed as above by the Committee constituted for the purpose.

Bank reserves the right to select or reject any or all applicants without assigning any reason thereof.

1.5. Time and date of opening Bid

1.5.1. The technical bid should be submitted within the timeline stipulated as per details provided in the GeM Portal. **BIDDER must ensure that all the documents uploaded / submitted signed by the authorized signatory.**

Eligibility cum Technical bids will be opened in the specified time mentioned in the GeM Portal. The Procurement Committee will evaluate the eligibility cum Technical Bids.

1.5.2 Commercial Bids:- After completion of the evaluation for the technical bid submitted, the Commercial bids for the successful bidders will be opened upon evaluation of the eligibility and technical bid by the Procurement Committee. The bidders should quote their commercial keeping in mind the followings:

- 1) Bid Rates as per the format enclosed in Annexure 1. The BIDDER shall indicate the Rates, Terms of Reference of which are given in the Technical Specifications.
- 2) The details of Rate Schedule for all the components of this Tender for which the BIDDER is intending to quote. Quoting rate for selective items that means if the bidder does not quote their commercial for all the items required by Bank will be outright cancelled.
- 3) The Commercial Bid must be as per the BoQ provided along with the Tender.
- 4) The rate quoted must be inclusive of taxes, transportation, and all.

1.5.3. Selection process

- a. The Financial Bids of technically qualified Bidders will be opened on the prescribed date.
- b. The Bidder, who has submitted the lowest Commercial bid, shall be selected as the **L-1** and shall be called for further process leading to the award of the contract.
- c. Only fixed price financial bids indicating total price for all the deliverables and services specified in this bid document will be considered.
- d. The bid price will include all taxes and levies and shall be in Indian Rupees.
- e. Any conditional bid would be rejected.
- f. **Errors & Rectification:** Arithmetical errors will be rectified on the following basis: "If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If there is a discrepancy between words and figures, the amount in words will prevail".

1.6. Validity of Tender: -

180 (One Hundred Eighty) days from the date of Submission of Tender.

1.7. Defect Liability Period: -

60 (Sixty) months from the date of completion of supply and installation in each location. Participation by the vendor to the tender process will tantamount that they unconditionally undertake to replace the items once identified as defective.

1.8. Performance Security Deposit: -

The contractor, whose tender is accepted, will be required to furnish by way of Performance Security Deposit/retention money by Bank Guarantee for the due fulfillment of this contract, such sum as will amount to 3.00% of the value of contract.

The Performance Security Deposit/Bank Guarantee shall be collected as per Bank standard and has to be deposited within 5 (five) days of issuance of Purchase Order. The Performance Security Deposit/Bank Guarantee shall be forfeited in full in case the vendor does not perform as per contract satisfactorily within the stipulated date mentioned in the award letter or cancel the contract.

1.9. Dispute Resolution: -

Bank and the selected bidder shall make every effort to resolve amicably, by direct informal negotiation, any disagreement or dispute arising between them under or in connection with this Tender. If after 30 days from the commencement of such informal negotiations, Bank and the selected bidder have been unable to resolve amicably a contract dispute; either party may require that the dispute be referred for resolution by formal arbitration.

All questions, disputes or differences arising under and out of, or in connection with the contract, shall be referred to sole Arbitrator appointed by Bank and the award of the sole arbitrator shall be final and binding on the parties. The arbitration and reconciliation act 1996 and revisions, if any, thereof, shall apply to the arbitration proceedings and the venue of the arbitration shall be at Kolkata only.

1.10. Other disciplines: -

1.10.1. GST, Service Tax, or any other tax on material in respect of this contract shall be payable by the Seller and the Bank will not entertain any claim whatsoever in this respect.

1.10.2. Delay in submission of any part arising due to postal or any other irregularities at any stage will not be considered. The Bank will not be responsible for any damage in transit in case of postal delivery / delivery through courier service or otherwise.

1.10.3. All tenders in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.

1.10.4. The acceptance of tender will rest with THE WEST BENGAL STATE COOPERATIVE BANK LTD and/or The State Level Procurement Committee, which does not bind itself to accept the lowest or any tenders and reserves to itself the right to reject any or all the tenders received without assigning any reason/s thereof.

1.10.5. In case the date of opening of tenders is declared as a holiday, the tenders will be opened at the same time on the next working day.

1.10.6. Conditional Tenders will be summarily rejected.

1.10.7. Defects liability period shall be as per memorandum. It must be realized that this period is for exposure of "Latent Defects". The DLP commences from the certified date of virtual completion, issued jointly by the Respective PACs and the Bank (WBSCB) or their representatives.

1.10.8. After opening the technical and commercial bids offer on the standardized conditions as depicted vide the tender document, no correspondence will be entertained.

1.10.9. Prior to opening of Commercial bid, THE WEST BENGAL STATE COOPERATIVE BANK LTD. or any person/organization Deputed by the Bank at their discretion may inspect the end point user of the previously Buyer Agency/Office as well as obtain confidential report from the concerned employers.

1.10.10. The bid of tenders who do not full fill the above criteria will summarily be rejected.

1.10.11. The Bank also reserves to itself the right of accepting the whole or any part of the tender and the tenderers shall be bound to perform the same at the rates quoted.

1.11 PAYMENT TERMS: - The payment will be made after complete supply and installation of Hardware items to designated addresses including demonstration of the use of the components to personnel of PACS. No part payment will be made against part supply.

1.12. Language of Bids:- The Bids prepared by the BIDDER and all correspondence and documents relating to the Bids exchanged by the BIDDER and the Bank, shall be written in the English Language, provided that any printed literature furnished by the BIDDER may be written in another language (Devnagari) so long as it is accompanied by an English version in which case, for purposes of interpretation of the Bid, the English version shall govern.

1.13. Bid Currency and Related: -

- 1) Rates should be quoted in Indian Rupees (INR) only.
- 2) The rates quoted should be including taxes and transportation.

1.14. Bid Rejection Criteria:

Bid may be rejected for any or all of the following grounds:

- The bidder's details attached to Tender are not found as per eligibility criteria.—
- RFP submitted with false and wrong information.—

Request for submission of Bids for selection of vendor for supply & installation of Hardware Items at 606 PACs located at different district of the State of West Bengal [version 2.0 dated 11.08.2023]

- Information requested by bank for this Tender process is not found in Technical and commercial offer.
- Misconduct and influence, if any, to this Tender process by the bidder OR its representative/s will result into rejection of bid document. No further communication will be entertained in this regard.

1.15.) Authorized Signatory: -

The Bidder shall submit the bid authenticated by an authorized person from any of their offices in India.

1.16.) Clarification on RFP Document: -

1. The Bidder shall carefully examine and understand the specifications /conditions of RFP, intent of the RFP and seek clarifications, if required, to ensure that they have understood all requirements/ specifications/ conditions/intent of Tender.

2. Bidders shall have the opportunity to get their doubts clarified pertaining to the Tender, prior to finalizing their responses. All questions are to be submitted to The Managing Director, The West Bengal State Co-operative Bank Ltd, 24A, Waterloo Street, Kolkata-700069, [E-mail: md@wbstcb.com] within seven days of Bid request submitted by the Bank.

Bank shall not answer any communication initiated by respondents after the last date of query submission. Bank may in its absolute discretion seek additional information or document from any respondents after the Tender closes for supplementary information and better evaluation. All such information and document provided will form part of that Respondent's response.

Bank is not bound to reply to queries not pertaining to this Tender. Replies shall be at Bank's discretion. Bank's replies shall be final and acceptable to all bidders.

1.17 Related Parties: - In the following circumstances Bank will have discretion to reject the entire bid or accept the bid with some conditions stipulated by bank –

- 1.17.1 Bids submitted by holding company and its subsidiary.
- 1.17.2 Bids submitted by one or more companies having common director/s.
- 1.17.3 Bids submitted by one or more partnership firms / LLPs having common partners.
- 1.17.4 Bids submitted by one or more companies in the same group of promoters/management.
- 1.17.5 Any other bid at the sole discretion of the Bank which is in the nature of multiple bids.

1.18 Special Instructions to the Bidders

- A.** While every effort has been made to provide comprehensive and accurate background information and requirements and specifications, Bidders must form their own conclusions about the SI support required. Bidders and recipients of this Tender may wish to consult their own legal advisers in relation to this Tender.
- B.** All information supplied by Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by the purchaser on the basis of this Tender.
- C.** No commitment of any kind, contractual or otherwise shall exist unless and until a formal written contract has been executed by or on behalf of the purchaser. Any notification of preferred Bidder status by the purchaser shall not give rise to any enforceable rights by the Bidder. Purchaser reserves rights to cancel this procurement at any time without any notice and reason.
- D.** This Tender supersedes and replaces any previous public documentation & communications, and Bidders should place no reliance on such communications.

1.19. Code of Integrity

- A.** No official of a procuring entity or a bidder shall act in contravention of the codes which includes
 - l. prohibition of
 - a. Making offer, solicitation or acceptance of bribe, reward or gift or any material benefit, either directly or indirectly, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process.
 - b. Any omission, or misrepresentation that may mislead or attempt to mislead so that financial or other benefit may be obtained or an obligation avoided.
 - c. Any collusion, bid rigging or anticompetitive behaviour that may impair the transparency, fairness and the progress of the procurement process.
 - d. Improper use of information provided by the procuring entity to the bidder with intent to gain unfair advantage in the procurement process or for personal gain.
 - e. Any financial or business transactions between the bidder and any official of the procuring entity related to Tender or execution process of contract; which can affect the decision of the procuring entity directly or indirectly.

- f. Any coercion or any threat to impair or harm, directly or indirectly, any party or its property to influence the procurement process.
 - g. Obstruction of any investigation or auditing of a procurement process.
 - h. Making false declaration or providing false information for participation in a bidding process or to secure a contract;
- II. Disclosure of conflict of interest.
- III. Disclosure by the bidder of any previous transgressions made in respect of the provisions of sub-clause (a) with any entity in any country during the last three years or of being debarred by any other procuring entity.
- B)** In case of any reported violations, the procuring entity, after giving a reasonable opportunity of being heard, comes to the conclusion that a bidder or prospective bidder, as the case may be, has contravened the code of integrity, may take appropriate measures.

1.20. Award of Contractor/Supplier

1.20.1. Award Criteria

Purchaser will award the Contract to the successful Bidder whose proposal has been determined to be substantially responsive and has been determined as the most responsive bids as per the process outlined above.

1.20.2. Right to Accept Any Proposal and to Reject Any of All Proposal(s)

Purchaser reserves the right to accept or reject any proposal, and to annul the bidding process / Public procurement process and reject all proposals at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Purchaser action.

1.20.3. Notification of Award

Prior to the expiration of the validity period, Purchaser will notify the successful Bidder in writing or by fax or email, that its proposal has been accepted. In case the bidding process/ public procurement process has not been completed within the stipulated period, Purchaser may like to request the Bidders to extend the validity period of the bid.

1.21 Force Majeure

Force Majeure is herein defined as any cause, which is beyond the control of the selected Bidder or Purchaser as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:

- A. Natural phenomenon, including but not limited to floods, droughts, earthquakes and epidemics.

- B. Acts of any government, including but not limited to war, declared or undeclared priorities, quarantines and embargos.
- C. Terrorist attack, public unrest in work area provided either party shall within 10 days from occurrence of such a cause, notifies the other in writing of such causes. The Bidder or Purchaser shall not be liable for delay in performing his/her obligations resulting from any force majeure cause as referred to and/or defined above. Any delay beyond 30 days shall lead to termination of contract by parties and all obligations expressed quantitatively shall be calculated as on date of termination. Notwithstanding this, provisions relating to indemnity, confidentiality survive termination of the contract.

1.22. No Employer-Employee Relationship

The selected bidder during the term of the contract and for a period of five years thereafter shall not without the express written consent of Purchaser, directly or indirectly: -

- 1.22.1 Recruit, hire, appoint or engage or attempt to recruit, hire, appoint or engage or discuss employment with or otherwise utilize the services of any person who has been an employee or associate or engaged in any capacity, by Purchaser in rendering the services in relation to the contract; or
- 1.22.2 Induce any person who shall have been an employee or associate of Purchaser at any time to terminate his / her relationship with NABARD/State Government/WBSCB.
- 1.22.3 Staff deployed by the vendor shall never be deemed to be appointed by the Purchaser nor shall they be governed by Purchaser's service conditions. The vendor should ensure statutory and regulatory compliance towards ESIC, EPFO, minimum wage requirements with regard to such staff as may be applicable from time to time.

1.23. Audit

- 1.23.1 The vendor/bidder shall allow purchaser, its authorized personnel, its auditors (internal and external), authorized personnel from RBI / other regulatory & statutory authorities, and grant unrestricted right to inspect and audit its books and accounts, to provide copies of any audit or review reports and findings made on the service provider, directly related to the services.
- 1.23.2 In case any of the services are further outsourced/ assigned/ subcontracted to other vendors, it will be the responsibility of the vendor to ensure that the authorities /officials as mentioned above are allowed access to all the related places, for inspection and verification.
- 1.23.3 Audit under this clause shall be restricted to physical files related to the arrangement. Audit shall be conducted during normal business hours and on normal working days after informing the vendor in advance.

1.24. Confidentiality

Information provided under this Tender and subsequent agreement, if any, is confidential and neither party shall at any time, either during the association or at any time, thereafter, divulge either directly or indirectly to any person, firm or company, business entity, or other organization whatsoever.

1.25. Representation and Warranties

In order to induce Purchaser, the vendor shall be deemed to have represented and warranted as follows:

- 1.25.1. That the vendor is a company which meets the requisite eligibility qualifications mentioned in Tender, and it has power and the authority to enter into agreement and provide the services, deliver sought by Purchaser.
- 1.25.2. That the vendor is not involved in any major litigation, potential, threatened and existing, that may have an impact of affecting or compromising the performance and delivery of services, systems.
- 1.25.3. That the representations made by the vendor in its bid shall be deemed to continue to remain true and the vendor continues to fulfil the requirements as are necessary for executing the duties, obligations and responsibilities as laid down in the RFP, unless Purchaser in writing specifies to the contrary, the vendor shall be bound by all the terms of the bid.
- 1.25.4. That the vendor has the professional skills, personnel and resources / authorizations that are necessary for providing services as are necessary to perform its obligations under the bid and the agreement.
- 1.25.5. That the vendor shall ensure that all assets including but not limited to databases, documents, etc. deployed and created during the term of the agreement are duly maintained and suitably updated, upgraded, replaced or substituted with regard to contemporary and statutory requirements. That the vendor shall procure all the necessary permissions, adequate approvals and licenses for use of various software and any copyrighted process / product free from all claims, titles, interests and liens thereon and shall keep Purchaser, its directors, officers, employees, representatives, consultants and agents indemnified in relation thereto.
- 1.25.6. That all the representations and warranties as have been made by the vendor with respect to its bid and agreement are true and correct, and shall continue to remain true and correct throughout the term thereof.
- 1.25.7. That the execution of the services herein is and shall be in accordance and in compliance with all applicable laws as amended from time to time and the regulatory framework governing the same.
- 1.25.8. That there are no legal proceedings pending or threatened against vendor or its team which adversely affect/may affect performance under this agreement; and no inquiries or investigations have been threatened, commenced or pending against the vendor or its team members by any statutory or regulatory or investigative agencies.
- 1.25.9. That the vendor has the corporate power to execute, deliver and perform the terms and provisions of the agreement and has taken all necessary corporate actions, consents and approvals to authorize the execution, delivery and performance by it of the agreement.

1.25.10. That neither the execution and delivery by the vendor of the agreement nor the vendor's compliance with or performance of the terms and provisions of the agreement (i) will contravene any provision of any applicable law or any order, writ, injunction or decree of any court or governmental authority binding on the vendor, (ii) will conflict or be inconsistent with or result in any breach of any of the terms, covenants, conditions or provisions of, or constitute a default under any agreement, contract or instrument to which the vendor is a party or by which it or any of its property or assets is bound or to which it may be subject or (iii) will violate any provision of the Memorandum and Articles of Association of the vendor.

1.26. Post Implementation Scope for the Operation and Maintenance

Comprehensive Onsite Warranty for a period of **5 years**.

1.27. HELPDESK SUPPORT

1.27.1 The selected bidder shall provide a centralized helpdesk for attending user request/ complaints. The helpdesk/customer care centre shall operate off-site (during working hours of the respective users (PACS) for the support period. However, bidder has to assign one person who will be the single point of contact for the PACS. Also, bidder should maintain one engineer for every 150 computers/hardware items to avoid delay in the service. Bidder may factor the same in their commercial proposal and no separate payment shall be made for the same by the purchaser. The nodal person should be graduate with at least minimum 8-10 years of experience in delivering the project.

1.27.2. The help desk service will serve as a single point of contact for all incident and service requests of the Hardware Service Provider. The service will provide a Single Point of Contact (SPOC) and also escalation / closure of incidents for the User departments (i.e PACS).

1.28. Packing and Documents

1.28.1. The selected bidder shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination. During transit, the packing shall be sufficient to withstand, without limitation, rough handling and exposure to extreme temperatures, salt and precipitation, and open storage.
