**(1) Scope of Work:**

The successful bidder [hereafter referred to as the Contractor] has to supply and install the prescribed specifications of Desktop Computers at each location and provide on-site comprehensive SBD [Same Working Day] warranty support for 3 years from the date of installation. **The selected bidder will be given the first level support services including formatting of the Computer OR other Hardware/Software including Operating System(OS) related issue within 2 working Hours from the time of call logging by Bank in either Telephonic/E-Mail to the selected bidder and provide the support services by selected bidder within 2 working hours from the time of call logging by Bank .If any Spare/Hardware related issue , the vendor will be responsible to registered the call to the OEM directly on behalf of the Bank and also monitoring the said Call . The vendor will provide the call ticket number to the Bank and also provided the call escalation matrix of the organisations at the time of Bid submissions.**

**The supplied Desktop Computer should be compatible with the existing Core Banking Solutions (CBS) under ASP model using B@ncs24 Solutions of M/S TCS Ltd. For any emergency situations the selected venfor will provide the support services in Sunday/Other Holiday's and Bank is not bound to give any extra payment for this purpose .**

**(2) Tender Validity:**

- The tenders shall be kept valid for a period of 45 days' from the last date of submission of tenders or any extended date as indicated below;
- In exceptional circumstances, WBSCB may solicit the bidder's consent for extension of the bid validity period. The request and the responses shall be made in writing. When the validity period is extended by the bidder, the same is to be done without any modification to the bid proposal by the bidder;
- All prices quoted must be firm and valid during bid validity period and extended periods. All prices quoted shall not be affected by any escalation in prices of labour or materials, machineries, equipment etc. or in rupee exchange rate during he bid validity period whatsoever.

(3) **Details of Submission of BID**

**(A) Bid Format:**

The vendor shall submit the technical and financial bid separately with the marking in the envelop. All the items mentioned in under following specification requirement should be quoted in the financial bid. Bank will not provide any Delivery/installation charges separately for supply of the said accessories at mentioned branches under Annexure -II .The financial bid should be submitted as per the following format:

The financial bid should be inclusive of all the taxes, levies, cost of freight, delivery and installation charges etc .Bank will not provide any delivery & Installation charges separately for the same.

**Bid Evaluation Process:**

**1.Compliance Against Eligibility Criteria**

The evaluation committee of Bank will decide whether the bidder’s response satisfies the stated eligibility criteria specified in the Tender Documents

Any shortfall [including omissions & variations] will be recorded. If a bid is not meeting the eligibility criteria, it shall be rejected and cannot be made eligible by correction or amendment.

**2. Examination of Short-listed Technical Bids**

The short-listed technical bids shall be examined for completeness and clarifications, if any, shall be sought for from the respective bidders in case the same is considered essential. Once the examination of the Technical Bids is completed, the Financial Bids of only those bidders whose technical bid is acceptable is to be opened.

**3. Examination of Short-listed Technical Bids**

WBSCB will determine whether the Financial Proposals, opened, are complete, i.e. whether the Bidder has included all components as per the Tender Document. If not, WBSCB may reject the bid as non-responsive. The Bank is not bound to accept the lowest bidders(L1) .

Financial Bids shall be compared for the complete scope of work as per the Price Proposal Schedule, inclusive of all taxes and duties. The price schedule shall also have the indicative price break-up.

After submission of the bid, all the bids submitted will be opened in presence of the evaluation committee of The West Bengal State Co-operative Bank Ltd(WBSCB). The Details of the bid evaluation will be intimated to the bidders once the evaluation is over. A single-step three-envelope bidding procedure will be used for the evaluation. Under this process, initially the **Qualification & Technical Bid** will be opened and examined. In the event there is any discrepancy, the bids are liable for immediate rejection.

If all the qualification criteria are fulfilled, then the bidders will be eligible for evaluation of Technical Bid. The evaluation of the bids will follow the steps outlined below.

#### **5.Uptime Calculations**

The service provider shall provide support services for the supplied Computer Systems on an annual average uptime of 99.5% on the systems , which will measured as follows :-

$\{[(\text{Actual Uptime} + \text{scheduled downtime})/\text{Scheduled Hours}] \times 100\}$  .The above percentage will be calculated monthly .

“actual uptime” will mean of the scheduled hours , the aggregate number of hours in any month during which each machines , is actually available for use .

“Scheduled Downtime” will mean the aggregate number of hours , in any month during which each machines is down during the scheduled hours , due to preventive maintenances , scheduled outages ,cabling faults ,infrastructure problems or any other situation which is not attribute to the service provider’s failure to exercise due care in performing its responsibility .

Scheduled Hours will mean the coverage hours from 9.30 AM to 7.30 P.M. for any working day’s .

#### **4.Other Terms and Conditions of Tender Documents**

1.The successful bidder will supply and install Personal Computer mentioned in Annexure I and other accessories at different sites as per Annexure II . The Purchaser Bank also reserves the right to place order for extra number of any or all the hardware items at the accepted Tender rates if so required;

2. That the vendor will be allowed two (02) weeks time to deliver and install the hardware at site after official intimation;

3.That the vendor shall pay liquidated damages @ 2% ( two per cent ) of the total unexecuted contract value per week subject to a maximum of 10% of the unexecuted contract value in case of delay of installation as per the time frame indicated above .However when the amount of the liquidated

damages is equivalent to 10% of the contract value, the Purchaser Bank will have the discretion to terminate the contract without any further reference;

4. That the Hardware delivered by vendor to the Purchaser must be covered by a comprehensive warranty for a minimum period of three (03) year warranty for Personal computers from the date of installation in respect of hardware;

### **7. Clause EMD value**

That the vendor shall furnish EMD in the form of Fixed Deposit(FD) for 3(three) years for an amount of 10% of hardware cost . The said Fixed Deposit is to be kept under lien in favour of the Bank. The said FD will be forfeited by Bank and realised by Bank , in the following cases :-

i) That if at any time the vendor’s performances are considered unsatisfactory by the Purchaser in regard to maintenance of service or supply of spares or any related matter affecting operational efficiency of the computer operation, the Purchaser Bank shall be at liberty to terminate the contract after issuing 10 day’s notice on the vendor and the Purchaser Bank shall be at liberty to invoke the Bank guarantee/EMD furnished by the vendor for liquidated damage @ 2 % per day subject to maximum of 10% of the contract value.

ii) In case of break down or glitches or snags of the Computer System vendor will be under obligation to restore the services of the computer system as mentioned under clause No 5 above within 2 working hours in the branch after receiving intimation from the Purchaser Bank either in writing or by Fax or telephonically or email during the period of warranty as well as during the subsistence of the maintenance period failing which the vendor firm shall pay liquidated damages @ 2 % per day of the contract value in respect of the projects where such recurring snags or glitches take place per day subject to a maximum of 10% of the cost of work order value executed by the vendor;

iii). That Vendor have to provide/maintain an extensive service support network for upcountry branches of The West Bengal State Cooperative Bank Ltd. located in the state of West Bengal;

iv). That vendor will bear all expenses for repair/replacement of the computer system installed by you instantly and this bank will not make any separate payment for any such expenses to be incurred by you within the comprehensive warranty period for Personal Computer (provided the breakdown is not due to negligence, faulty electrical points/ mains, act of nature & others including unprepared/ unclean site)

but the purchaser bank will bear the cost of labour for Personal Computer during limited warranty period ;

v). That Bank may like to arrange for independent/outside and/or in-house team for testing and certification of hardware;

vi). That you will transfer ownership of the equipments in favour of the Bank and the same shall be effected as soon as the equipments is brought to the sites of the bank's premises, installed thereafter and accepted by the bank;

### **8. Fidelity Clause**

i). That the vendor shall strictly undertake not to communicate or allow to be communicated to any person or divulge in any way any information relating to ideas, concepts, know how, techniques, data, facts, figures and all information whatsoever concerning or relating to the bank and its affairs to which the said employees have access in the cause of performance of contract. You and such employees shall also execute letters of fidelity and secrecy in such forms as may be prescribed by the Purchasing Bank. Failure to adhere to this clause may call for action culminating in termination of the contract;

ii.) That the Vendor shall explicitly absolve the bank of any responsibility/liability for any routine breakdown or mal-functioning of the computers resulting from failure of the computer system or the hardware (provided the breakdown is not due to negligence, faulty electrical points/ mains, act of nature & others including unprepared/ unclean site);

iii.) That vendor have to extend facilities to avail advantages like technological upgradation in the higher side and price revision in the lower side of Personal Computers without any dispute. The bank will not bear the risk of product obsolescence;

1v). That the Vendor have to supply technologically higher configured product after taking written consent from the bank if the ordered product is withdrawn from the market in the due course;

v.) That the Vendor have to provide details of contact person, telephone number, email Id, facsimile number for providing service support in the respective sites during the time of warranty period;

vi.) That the Vendor have to furnish letter of acceptance signed by authorised signatory by mentioning the acceptance of Order and abide by all the clauses during the time of warranty period in black and white;

vii.) That the delivery of hardware will start in respective places/sites in a phased manner after getting official intimation from time to time;

viii. Any Dispute between Service Provider & Purchaser Bank in the matter of interpretation of any or all clause of the terms & conditions shall be adjudicated in Kolkata within the Jurisdiction of Hon'ble Kolkata High Court.

### **9. Payment Terms**

The Bank will release payment in the following mannner :

- i) 50% of the billed amount will be released by the Purchaser Bank on receiving delivery of the hardware with preloaded software and the hardware supplied by the vendor should be strictly in conformity with the specification of the order and should also conform to HP's specification of various hardware components (to be supplied by HP);
- ii) 35% of the billed amount after the computer Hardware is installed and being free from operational defect;
- iii) Further 15% of the billed amount for Hardware is to be released 7 days after the date of installation and furnishing of bank guarantee/EMD value ;
